DURATION**

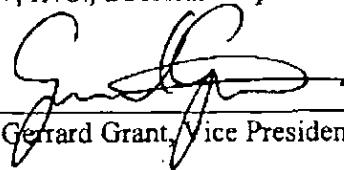
The Company's existence shall commence effective February 19, 2019 and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.

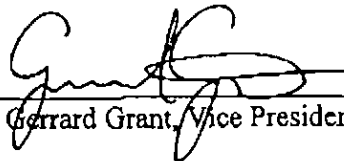
