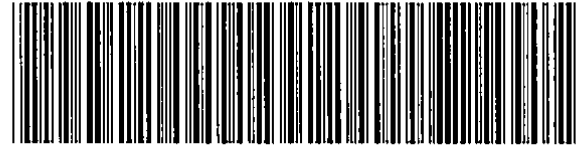

and agents from such liability to the fullest extent permitted by law


### **ARTICLE VIII Amendments**


