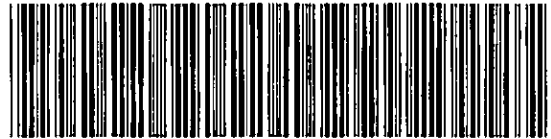

The undersigned, being a Member of **SOLWAY CONSTRUCTION, LLC**, a Florida Limited Liability Company, for which the Articles of Organization were filed on July 15, 2019, and assigned Document Number 1.19000180789, having specific authority to make this filing provided by the unanimous written consent of all Members of **SOLWAY CONSTRUCTION, LLC**, hereby files these Amended and Restated Articles of Organization of **SOLWAY CONSTRUCTION, LLC**, as follows:

ARTICLE I - NAME

The name of the Limited Liability Company shall be **SOLWAY CONSTRUCTION, LLC** (the "Company").

ARTICLE VIII - REGISTERED OFFICE AND REGISTERED AGENT

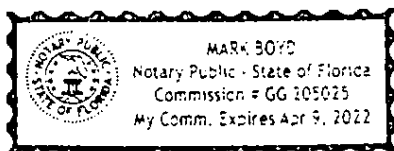
