FIRST AMENDMENT TO ARTICLES OF ORGANIZATION OF ALTIS VINELAND POINTE REALTY, LLC (Document No. L19000182732)

Pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, the Articles of Organization of Altis Vineland Pointe Realty, LLC, a Florida limited liability company (the "Company"), dated as of July 26, 2019 (the "Original Articles of Organization") are hereby amended and modified under the laws of the State of Florida as follows:

In the event of any conflict between the terms and provisions of the Original Articles of Organization and the terms and provisions of this First Amendment to Articles of Organization of Altis Vineland Pointe Realty, LLC, the terms and provisions of this First Amendment shall govern and control.

3. Authority. This First Amendment to Articles of Organization of Altis Vineland Pointe Realty, LLC is adopted and approved by the members and managers of the Company pursuant to the terms and provisions of that certain Operating Agreement of Altis Vineland Pointe Realty, LLC dated effective as of July 26, 2019.
