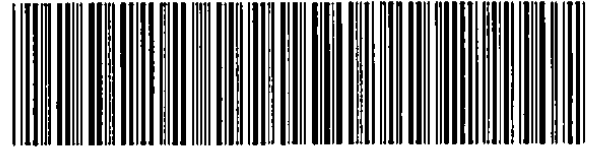


**ARTICLE III.


