ARTICLES OF ORGANIZATION**

Effective at 12:01 a.m. on the date of this filing, 13M Villages, LLC, a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby submit the following Articles of Organization pursuant to Section 605, Fla. Stat.

**ARTICLE 1
NAME**

The name of the limited liability company shall be **13M Villages, LLC**.

**ARTICLE 2
DURATION**

The period of duration of the Limited Liability Company shall be perpetual, unless the Limited Liability Company is dissolved pursuant to provisions of the Florida Limited Liability Company Act, the Articles of Organization of the Limited Liability Company, or the Operating Agreement of the Limited Liability Company.

**ARTICLE 3
PURPOSE**

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE 4
STREET ADDRESS OF PRINCIPAL OFFICE**

**ARTICLE 5
MANAGEMENT**

The Company shall be managed by one manager. The name and address of the persons who shall serve as managers until the next meeting of members or until their successor is elected and qualified are as follows: 13M Villages Trust, u/a/d September 27, 2019, currently residing at 1028 Lake Sumter Landing, The Villages, FL 32162. The managers shall be elected as provided in the Operating Agreement.

**ARTICLE 6
ADMISSION OF ADDITIONAL MEMBERS**

Members shall have the right to admit additional members pursuant to the Operating Agreement adopted by the Company.

**ARTICLE 7
MEMBERS RIGHTS TO CONTINUE BUSINESS**

The right of the remaining members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company, shall be carried out as provided for in the Operating Agreement adopted by the Company.




