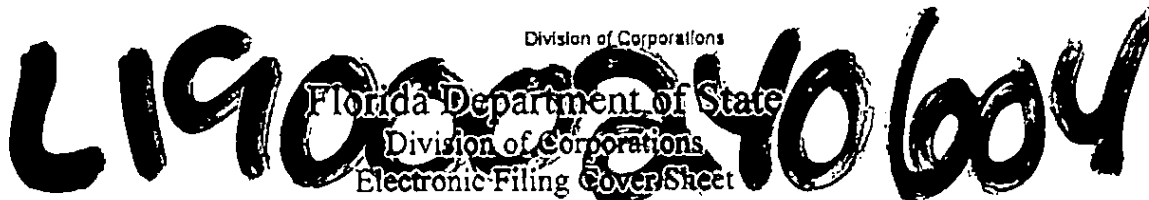

Management of the Company


