Florida Not for Profit Corporation

The undersigned hereby adopts the following articles of incorporation in Compliance with Chapter 617, E.S., (Not for Profit).

Article 1 Name

The name of this corporation shall be Foundation Jesus Loves You USA - Fundación Jesus Te Ama USA, Inc.

Article 2 Principal Office

Article 3 Purpose


Article 11 Bylaws
