The undersigned, who intend to form and create a Limited Liability Company, as defined in Chapter 605 of the Florida Statutes, do hereby state and certify the following:

- 1. Name. The name of the Limited Liability Company shall be 103 CLEARWATER, LLC.
- 2. <u>Duration of Company</u>. The company shall have perpetual duration.
