To Whom It May Concern:

I, Veronica Hiegemann, in my capacity as ONLY owner of VMANN LLC, submit this Statement of Facts regarding the erroneous filing of the Articles of Dissolution for the above-referenced entity.

1. Filing in Question:

On or about 07/16/2024, Articles of Dissolution were filed with the Florida Department of State, resulting in the entity being marked as dissolved. Attached is the Articles of Dissolution that was filed by a gentleman by the name of Vicent Manno, whom is a complete stranger to me and I have no idea why this happened. This was noticed when filing for annual report and was unsuccessful due to the company being Inactive to my surprise.

2. Error in Filing:

The Articles of Dissolution were filed in error and were **Veronica Hiegemann, sole owner of VMANN LLC** never agreed to. Specifically, the filing was made by Vincent Manno, who did **not have the proper authority** to dissolve the entity. After speaking to a representative of the Florida Department of State, we realized that Vincent Manno has a company with the name of VMAN LLC. Therefore the reason why I suspect that this was a mistake on his part since I never filed for such Article of Dissolution. See attached search list for reference of similarities in names of the companies.

3. Current Status:

The entity (VMANN LLC) did not intend to dissolve and has continued to operate in good faith, unaware of the erroneous dissolution until 04/09/2025. Upon discovery, immediate steps were taken to address and rectify the issue, which has led me to send this letter as instructed by the representative I spoke to on the phone from the Florida Department of State.

4. Requested Action:

We respectfully request that the Florida Department of State, reverse or withdraw the erroneous Articles of Dissolution, and reinstate the entity to active status, retroactive to the date of dissolution.
