**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF
PR GLOBAL RESERVATIONS LLC**

These Articles of Amendment to the Articles of Organization of PR Global Reservations LLC, a Florida limited liability company (the "Company"), are hereby set forth in accordance with Section 605.0202 of the Florida Revised Limited Liability Company Act:

FIRST: The Articles of Organization of the Company were filed on February 28, 2020, and assigned Florida document number L20000063936.

SECOND: The Articles of Organization of the Company are hereby amended as follows:

- 1. Article II is hereby deleted in its entirety and replaced with the following:

ARTICLE II - ADDRESS

- 2. The first sentence of Article III is hereby deleted in its entirety and replaced with the following:

- 3. An Article V is hereby added, stating the following:

ARTICLE V - MANAGER

The initial manager of this Company shall be Marisel Perez, with an address of 8400 NW 33rd Street, Suite 406, Doral, Florida 33122.

THIRD: Except as expressly provided herein, all of the terms and provisions of the Articles of Organization of the Company shall remain in full force and effect and are hereby ratified and confirmed.
