5. Management. The Company shall be a manager managed company, the name and address of the initial manager are:

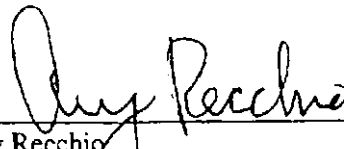
