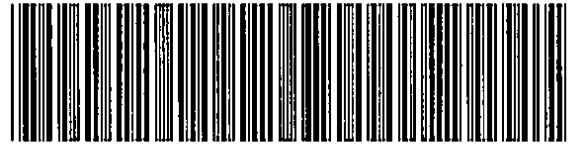


1. **Name.** The name of the Company is **Fine By Me, LLC**.
