The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

### ARTICLE 1 - NAME

The name of the limited liability company shall be **GENERAL SERVICES BOLIVAR LLC** ("Company").

### ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 13148 Heather Moss Drive, Apt. 309, Orlando, Florida 32837 and the mailing address shall be the same.

### ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

### ARTICLE 4 - DURATION

**ARTICLE 6 - REGISTERED OFFICE AND REGISTERED AGENT**




