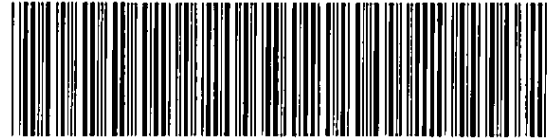

FIRST: Article I is amended and restated to read as follows:


