ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is **Florida Funders Fund Management 2, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

The undersigned executed these Articles of Organization on the 30th day of June, 2020.


