**ARTICLES OF ORGANIZATION OF**  
**2485 DCG HOLDINGS, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act (the "Act") of the State of Florida pursuant to Chapter 605 of the Florida Statutes hereby makes, acknowledges, and files the following Articles of Organization providing for formation, rights, privileges, and immunities of limited liability companies for profit.

**ARTICLE I**  
**NAME**

The name of the limited liability company shall be 2485 DCG HOLDINGS, LLC (the "Company").

**ARTICLE II**  
**MAILING ADDRESS**

The mailing address for the Company shall be 16731 NW 87<sup>th</sup> Court, Miami Lakes, FL 33018.

**ARTICLE III**  
**INITIAL REGISTERED OFFICE AND REGISTERED AGENT**

The address of the initial registered office of the Company is 16731 NW 87<sup>th</sup> Court, Miami Lakes 33018 and the name of the company's initial Registered Agent for service of process in the State of Florida at that address is Daniel Gamez.

**ARTICLE VII  
MEMBERSHIP RESTRICTIONS**

Additional Members may be admitted to the Company only upon the unanimous consent of existing Members of the Company. Contributions required of new Members shall be determined as of t time of admission to the Company in accordance with the Operating Agreement of the Company Member's interest in the Company shall be considered personal property, notwithstanding the actual natur the assets owned by the Company, and may not be sold or otherwise transferred except in strict accorda with the Operating Agreement of the Company.

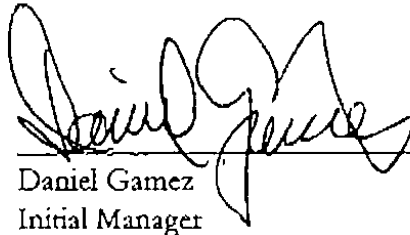
**ARTICLE VIII

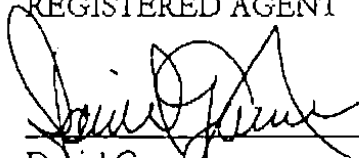
