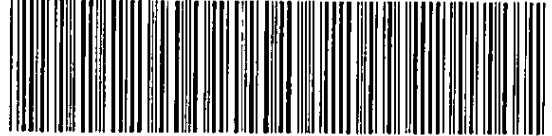

The conversion shall be effective in Florida upon filing.

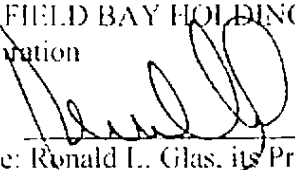

The name of the limited liability company is: ALLY INVESTORS MW, LLC.

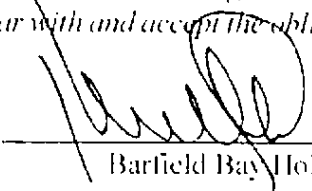

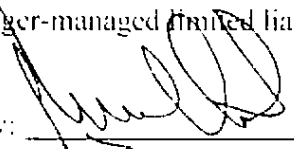
