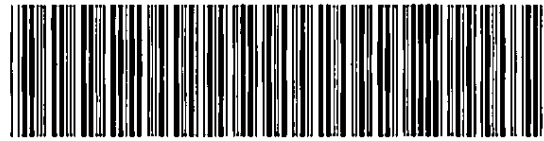

**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF
BB X ROSETTA, LLC**

Pursuant to the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, **BB X ROSETTA, LLC**, a Florida limited liability company (hereinafter, the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The Articles of Organization of BB X ROSETTA, LLC were filed with the Florida Department of State on October 6, 2020 and assigned document number L20000304452.

SECOND: The Company's Articles of Organization are hereby amended by deleting Article I of the Articles of Organization and replacing it with the following new Article I:

"ARTICLE I. NAME

The name of the limited liability company Rosetta Bakery x Best Buddies, LLC."

THIRD: Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.

FOURTH: The effective date of these Articles of Amendment is January 14, 2021.
