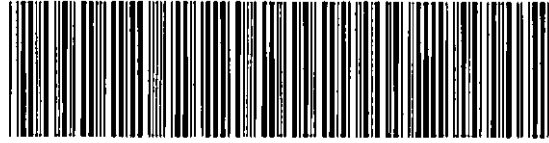

**AMENDMENT TO
ARTICLES OF ORGANIZATION

This will be a manager-managed company. The names and addresses of the Managers of the Company are:


