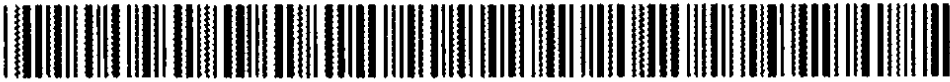


1. NAME. The name of the Limited Liability Company is: **SKY COVE SOUTH, LLC** (the "Company").


