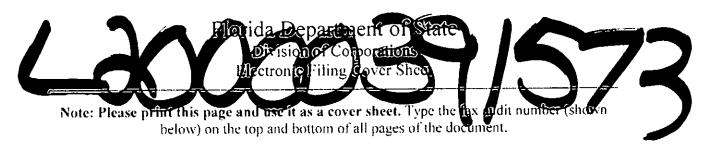

# AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF RIOLEE LLC
