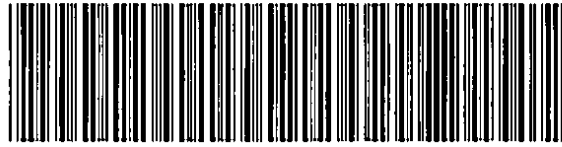

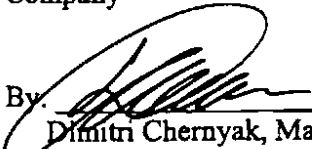
ARTICLES OF CONVERSION
