**ARTICLES OF ORGANIZATION

ARTICLE I - NAME

The name of the limited liability company is 30A Pathway to Bliss, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."


ARTICLE VI - MANAGEMENT


