

# ARTICLES OF ORGANIZATION OF FERRANDO PROPERTIES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

## ARTICLE 1 - NAME

The name of the limited liability company shall be FERRANDO PROPERTIES, LLC

#### ARTICLE 2 – ADDRESS


The principal place of business of the Company in Florida shall be 8180 nw 36 th street Suite 308A, Doral FL, 33166 and the mailing address shall be the same.

## ARTICLE 4 - DURATION

## ARTICLE 7 - ADMISSION OF NEW MEMBERS

A member may transfer his o her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no rights to participate in the management of the business and affairs of the Company or become a member unless all the others member(s) of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

## ARTICLE 8 - TERMINATION OF EXISTENCE

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least one remaining member.
