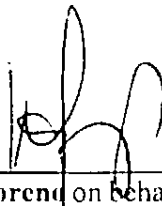

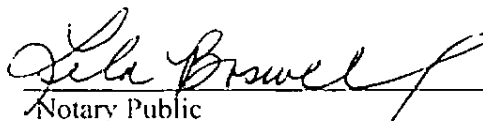
1. That I am over the age of eighteen years old and have the personal knowledge and authority to make this affidavit.

3. That INN & RELAX CORP. was administratively dissolved on February 4, 2021.

5. INN & RELAX CORP. has no intention of revoking the administrative dissolution entered on February 4, 2021.

7. The purpose of this Affidavit is to ensure that the name "INN & RELAX" may be used by another entity immediately and is provided to the Department of State to facilitate such use by another entity without the need for waiting the full 120 days after the effective date of dissolution.
