

# ARTICLES OF ORGANIZATION OF WP MIAMI LLC

The undersigned, being a duly authorized representative of the Members, desiring to form a limited liability company pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

#### ARTICLE I NAME

The name of the limited liability company is WP MIAMI LLC (the "Company").

# ARTICLE V MANAGEMENT

The Manager(s) shall also have the rights and responsibilities described in the Operating Agreement of the Company, if applicable. The Manager(s) shall serve in such capacity until their successor(s) are duly elected and qualified. All Managers, other than the initial Managers shall be appointed or elected solely as provided in the Operating Agreement of the Company, if applicable, and otherwise by the Members.

The power to alter, amend, or repeal the Articles of Organization of the Company shall be only upon the unanimous written consent of all of the existing Members of the Company or in accordance with the procedures set forth in the Operating Agreement of the Company, if applicable
