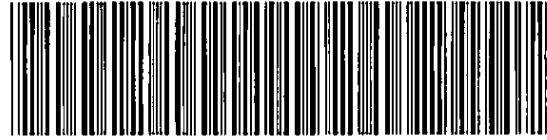

**ARTICLES OF ORGANIZATION
OF LA COLMAR BAKERY & BISTRO, LLC**

The undersigned, as the Managers of this limited liability company pursuant to Chapter 605 of the Florida Statutes, hereby form a limited liability company under the laws of the State of Florida and adopt the following Articles of Organization for said limited liability company:

ARTICLE I - NAME OF LIMITED LIABILITY COMPANY
