**ARTICLES OF ORGANIZATION
OF
180 CONSTRUCTION AND COMMUNITY
DEVELOPMENT ALLIANCE LLC**

a Limited Liability Company organized under the laws of the State of Florida

The Undersigned, acting as members of a limited liability company under the Florida Revised Limited Liability Company Act, Fla. Stat. Chapter 605, hereby make, acknowledge, and file the following Amended Articles of Organization;

**ARTICLE I.
NAME**

The name of the limited liability company shall be **180 CONSTRUCTION AND COMMUNITY DEVELOPMENT ALLIANCE LLC**, a Florida limited liability company (the "Company").

**ARTICLE II.
ADDRESS**

The Amended Operating Agreement of the Company will be executed by each member of the Company and will set forth all provisions for the affairs of the Company and the conduct of its business to the extent that such provisions are not inconsistent with law or these Articles.

**ARTICLE VII.
CAPITAL CONTRIBUTIONS**

The members of the Company shall contribute to the capital of the Company the cash or property set forth in and described in the Amended Operating Agreement.

**ARTICLE VIII.
ADDITIONAL CAPITAL CONTRIBUTIONS**

Each member shall make additional capital contributions to the Company only on the consent of the members as set forth in the Amended Operating Agreement.

**ARTICLE IX.
ADMISSION OF NEW MEMBERS**

No additional members shall be admitted to the Company unless done so pursuant to the terms of the Amended Operating Agreement. A member may only transfer his or her interest in the Company as set forth in the Regulations and Amended Operating Agreement of the Company.

**ARTICLE X.
MANAGEMENT**

The Company shall be managed by a **manager** or **managers** in accordance with the Amended Articles of Organization, the Amended Operating Agreement, the Regulations adopted by the members for the management of the business and the ordinary and customary affairs of the Company. The Regulations and the Amended Operating Agreement, if any, shall determine the manner in which such the Manager(s) are elected and appointed, and may contain any provisions for the regulation and management of the affairs of the company not inconsistent with the law or these Articles of Organization. 
- [a] Conducted himself/herself/itself in good faith;

This company shall pay for or reimburse the reasonable expenses of the individual pursuant to the Revised Florida Limited Liability Company Act.


**ARTICLE XIII.




