**ARTICLES OF ORGANIZATION
OF
FOR YOU MARKETING, LLC**

The undersigned, for the purpose of forming a single member Florida limited liability company under the Florida Revised Limited Liability Company Act, F.S. Chapter 605, (the "Act") hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be For You Marketing, LLC ("Company"); provided, however, that the member may, to the extent permitted by the Act, change the name of the company at any time or from time to time and cause the company to do business at the same time under one or more fictitious names if the member deems it is in the best interest of the company.

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the Company is 600 SW 3rd Street, Pompano Beach, Florida 33060.

ARTICLE III -- DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State, Division of Corporations. The Company's existence shall be perpetual unless the Company is dissolved earlier as provided in these Articles of Organization or in the Operating Agreement.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

ARTICLE V -- MANAGEMENT

The Company shall be managed by the single member or its elected managers in accordance with Operating Agreement adopted by the single member for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
