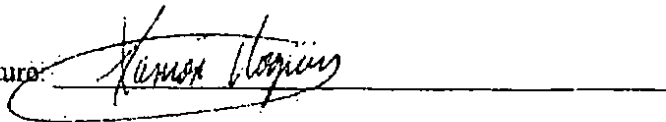

Continuity of Life

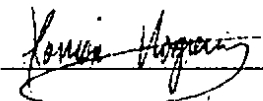
