
**ARTICLE VII

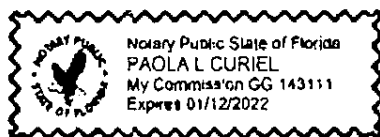
