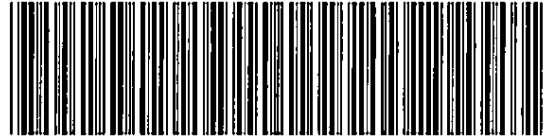

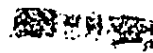

**SECOND AMENDMENT TO  
ARTICLES OF ORGANIZATION

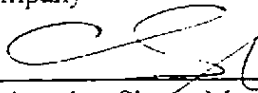
