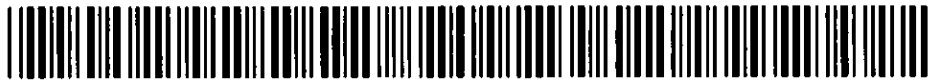


**ARTICLE IV**
