

ARTICLE VII-INDEMNITY

IB) THE L.L.C. SHALL PROVIDE TO ANY PERSON WHO IS OR WAS A GENERAL MANAGER, EMPLOYEE OR AGENT OF THE L.L.C. OR IS OR WAS SERVING AS THE REQUEST OF THE L.L.C. AS A GENERAL MANAGER, EMPLOYEE OR AGENT OF THE L.L.C., PARTNERSHIP, FOINT VENTURE, TRUST OR ENTERPRISE, THE INDEMNITY AGAINST EXPENSES OF SUIT, LITIGATION OR OTHER PROCEEDINGS WHICH IS SPECIFICALLY PERMISSIBLE UNDER APPLICABLE LAW.

(C) THE GENERAL MANAGER MAY, IN THEIR DISCRETION, DIRECTS THE PURCHASE OF LIABILITY INSURANCE BY WAY OF IMPLEMENTING THE PROVISIONS OF THIS ARTICLE.

ARTICLE VII-CONTRACTS, LOANS, CHECKS, AND DEPOSITS

SECTION 3: <u>CHECKS_DRAFTS_ETC</u>_ALL CHECKS, DRAFTS OR OTHER ORDERS FOR THE PAYMENT OF MONEY, NOTES OR OTHER EVIDENCES OF INDEBTEDNESS ISSUED IN THE NAME OF THE L.L.C., SHALL BE SIGNED BY SUCH MANAGERS, AGENT OR AGENTS OF THE L.L.C. AND IN SUCH MANNER AS SHALL FROM TIME TO TIME BE DETERMINED BY RESOLUTION OF THE GENERAL MANAGERS.

SECTION 4. <u>DEPOSITS</u>, ALL FUNDS OF THE L. U.C. NOT OTHERWISE EMPLOYED SHALL BE DEPOSITED FROM TIME, TO TIME TO THE CREDIT OF THE U.L.C. IN SUCH BANKS, TRUST COMPANIES OR OTHER DEPOSITORIES AS GENERAL MANAGERS MAY SELECT.
