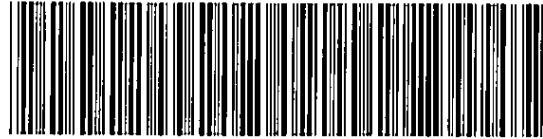

MANAGEMENT**




