**AMENDED AND RESTATED ARTICLES OF ORGANIZATION  
OF  
FEDERAL EMPLOYEE LOANS  
LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes, hereby makes, acknowledges and files the following Amended and Restated Articles of Organization (the "Articles"), which amend and restate the Company's initial Articles of Organization filed on February 11, 2022.

**ARTICLE I. NAME**

The name of the limited liability company is FEDERAL EMPLOYEE LOANS LLC (the "Company").

**ARTICLE II. MAILING AND STREET ADDRESS**
