
ARTICLE V  
MANAGEMENT AND POWERS

The business and affairs of the Limited Liability Company shall be managed by one or more Managers elected as provided in the Operating Agreement of the Limited Liability Company.

ARTICLE VI  
PURPOSE

Subject to the more specific purpose(s), if any, set forth in the Operating Agreement, the purpose of the Company is to engage in any lawful act or activity for which a limited liability company may be formed within and according to the laws and regulations of the State of Florida ("Applicable Law.") Specifically, the Company is organized as a "Qualified Opportunity Fund" to invest in "Qualified Opportunity Zone Property" (as such terms are defined in Title 26, Subtitle A, Chapter 1, Subchapter Z ("Subchapter Z") of the Internal Revenue Code of 1986, as amended ("Code"), and Treasury Department Regulations promulgated thereunder ("Treasury Regulations"), as the same may be amended or modified from time to time ("QOZ Laws and Regulations"), and which Qualified Opportunity Zone Property (i.e. "Qualified Opportunity Zone Business Property" and/or "Qualified Opportunity Zone Business") relate(s) to one or more trade(s) or business(es) operated in the United States, the District of Columbia or a United States possession, including the Commonwealth of Puerto Rico. As a Qualified Opportunity Fund, the Company may not invest in other Qualified Opportunity Funds. The Company shall conduct its business and affairs in substantial compliance with QOZ Laws and Regulations and in a manner necessary or appropriate to continue to qualify the Company as a Qualified Opportunity Fund and to make available to Members in the Company the tax benefits associated with their investment in a Qualified Opportunity Fund as set forth in QOZ Laws and Regulations.
