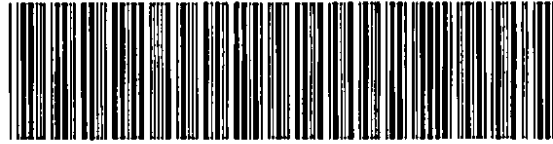

Erase Ammendment 3 and add the following:

Demetrios Theodossakos will have 65% ownership (in every aspect) and Dylan Rothstein will have 35% ownership of Afford Now LLC. Selling of Equity will be sold equivalently up until the end of the seed stage or 15% of the company is sold. After, it will be sold proportionately to equity owned. Owners can sell as much or little equity as they want after the Serie A round. Demetrios or Dylan (owners) will have the right to refuse but must match the offer if this right is brought up. Demetrios Theodossakos will always have .25% more equity than Dylan Rothstein unless Demetrios Theodossakos sells his own equity to become a lesser owner than Dylan.

An owner can not create a competing business or attempt to dissolve the business. Dylan Rothstein and Demetrios Theodossakos will make the same salary once profitable and working full time. Dylan Rothstein and Demetrios Theodossakos will put in the same amount of time for the duration of the business.

If an owner wants to leave the business or stop, they can't do anything to harm the business. After Serie A round share can be sold with out it being proportionate to equity.
