

ARTICLES OF ORGANIZATION

OF

P66 VILLA 2, LLC

The undersigned, acting as the organizer of P66 Villa 2, LLC, under the Revised Florida Limited Liability Company Act, Chapter 605, Fla. Stat., adopts the following Articles of Organization:

ARTICLE I - Name:

The name of the limited liability company is P66 Villa 2, LLC (the "Company").

ARTICLE VII - Initial Registered Agent and Office:



ARTICLE IX - Continuation of Business:
