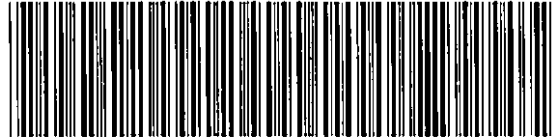

The name of the Limited Liability Company is "**Adams Street Residential, LLC**" (the "**Company**").

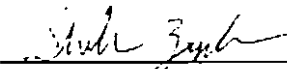
