**ARTICLES OF ORGANIZATION
OF
USIE CONSULTING SERVICES, LLC**

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act ("Act"), does hereby adopt the following Articles of Organization for such company.

**ARTICLE I
NAME**

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is, **USIE CONSULTING SERVICES, LLC**.

**ARTICLE II
ADDRESS**

The Company's street address of its principal place of business in Florida is 7255 Flood Reef, Pensacola, FL 32507, and its mailing address is 7255 Flood Reef, Pensacola, FL 32507, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

**ARTICLE III

**ARTICLE V
OPERATING AGREEMENT**

An Operating Agreement adopted by the members or by the manager may be repealed or altered, new operating agreement may be adopted by the members, and the members may prescribe in any operating agreement made by them that such operating agreement may not be altered, amended or repealed by the manager.

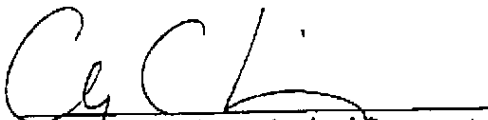
**ARTICLE VI
AMENDMENT TO ARTICLES**

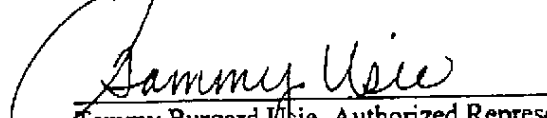

No Member shall have any vested right pursuant to these Articles that cannot be removed by amendment of these Articles. Each of the Members shall enter into an Operating Agreement for the Company containing such terms and conditions as are agreed upon by the Members.

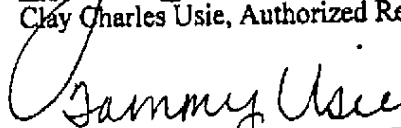
**CERTIFICATE OF DESIGNATION OF

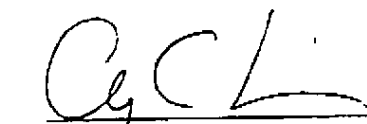
