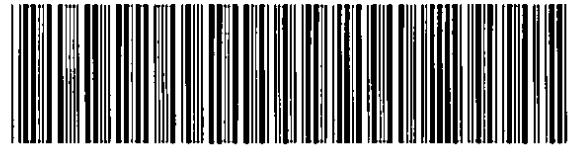

The name of the Limited Liability Company is Emerald Coast Vacation Rentals & Sales, LLC.

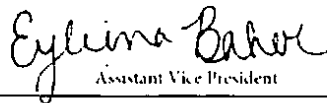
