**AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF  
EVERYTHING INTERIOR AND INNOVATED EXTERIOR, LLC,  
A FLORIDA LIMITED LIABILITY COMPANY**

- A. EVERYTHING INTERIOR AND INNOVATED EXTERIOR, LLC (the "Company") was formed as a limited liability company under the Florida Revised Limited Liability Company Act through the filing of the Articles of the Organization of the Company with the Florida Department of State, Division of Corporations on July 18, 2022.
- B. The Articles of Organization of the Company are hereby amended and restated in their entirety as follows:
  - (1) The name of the Company is: **Everything Interior and Innovated Exterior, LLC.**
  - (2) The Company is formed for the purpose of engaging in the interior design business and related activities, and to perform any acts permitted to the Company in furtherance thereof as permitted by applicable law
  - (3) The principal office and mailing address of the Company in the State of Florida is: **3599 Grand Cypress Drive, Naples FL 34119.**
  - (4) The name and address of the resident agent of the Company in the State of Florida are: Corporate Creations Network Inc., 801 US Highway 1, North Palm Beach, FL 33408.

  - (6) The business and affairs of the Company shall be governed by a written operating agreement of the Company executed by all the members of the Company (as constituted from time to time). The authority of any member or other person to act on behalf of the Company shall be solely as set forth in such written operating agreement.
