THESE AMENDED & RESTATED ARTICLES OF ORGANIZATION (the "Amended & Restated Articles") of CASPIAN PERFORMANCE GROUP LLC, a Florida limited liability company (the "Company"), are submitted in accordance with §605.0202 of the Florida Revised Limited Liability Company Act (the "Act") for purposes of amending and restating the Articles of Organization of the Company in their entirety. 
