ARTICLE II – ADDRESS

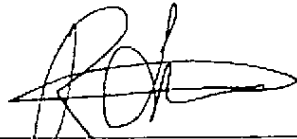

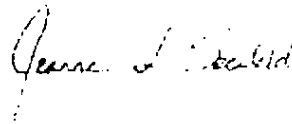
