**ARTICLES OF ORGANIZATION

The undersigned, Ashley Cole, a natural person competent to contract and an authorized representative of KCA COLE, LLC, hereby presents these Articles of Organization as the Articles of Organization of KCA COLE, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is KCA COLE, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."


ARTICLE VI - MANAGEMENT


