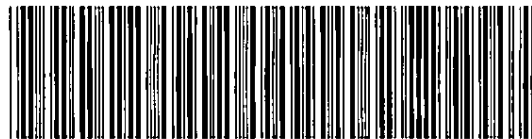

ARTICLE IX - MANAGEMENT

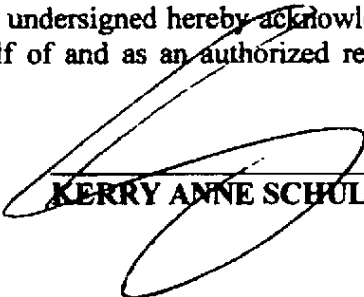
The Company shall be manager-managed in accordance with the Operating Agreement of the Company as adopted and agreed upon by the members.
