
ARTICLE VI

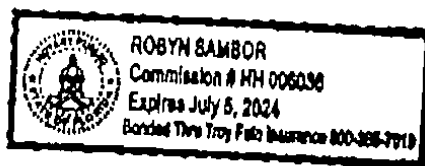

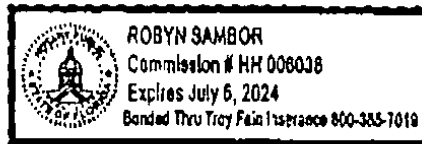
