As per your instructions during our call on 6/25/24, please notice this Notarized Statement of Fact in reference to the request for removal of a fraudulent amendment filed with the FL SOS Division of Corporations by a Mr. Glenn Straub, dated May 14 published on May 20, 2024 for Miss America Competition, LLC. (Document No. L23000003074).

Mr. Glenn Straub's amendment changes: the Entity Name, the designated 'Manager', the official place of business, and Registered Agent all in one amendment application. Mr. Glenn Straub acted on his own accord without any authority to change the ownership, and the records of ownership, of Miss America Competition, LLC. The only verifiable fact on this fraudulent amendment is Mr. Glenn Straub's formal acknowledgement of my position as Manager of the LLC when using the word MGR to note my position. In addition, please see the following facts:

- 1. At no time has there ever been an entity named Miss America CompetitionS ending with an S.
- 2. The name change amendment dated 1/12/2023 from Miss America Pageant to Miss America Competition was published in March 2023, due to the backlog of applications to the FL SOS.
- 3. The FL SOS clerical error (adding an S to Miss America Competition) was rectified to be reflected on the official website by the Secretary of State in May 2024.
- 4. Mr. Straub's amendment filing is an attempt to change the NAME RECORD, without filling out a name change amendment to note any proposed name change, while lacking authority to do so.
- 5. At all times, I have been from inception to present day the only Manager of Miss America Competition LLC Document number L23000003074 and recognized by IRS EIN filings as the Sole Member.
- 6. I have never signed any document or authorized anyone on my behalf to sign any document conveying this LLC to any individual person or entity, in whole or in part, and/or to add any Members or Managers, at any time from December 28, 2022 until present.
- 7. I have never signed any contract that would give any individual or entity authority to change any records with Florida SOS records on my behalf.
- 8. Mr. Glenn Straub is not a relative by birth, marriage or adoption, or in any fashion my designated Successor authorized to sign any documents on my behalf.

Respectfully, please correct the records for Miss America Competition LLC Document No. L23000003074 with the Florida Secretary of State, Division of Corporations. At your suggestion, I am seeking a Court Order to prevent any more attempts by Mr. Glenn Straub to make changes to any of my entities.
